ADVISORY ON HANDLING OF PUBLIC HEALTH PESTICIDES AND REPELLENTS IN SINGAPORE

This advisory is to remind stakeholders on the proper handling of public health pesticides/repellents for use against the five vectors (mosquitoes, flies, rats, cockroaches and rat fleas).

- There have been incidences where end users used unregistered pesticides/repellents purchased from e-commerce platforms. Under the Control of Vectors and Pesticide Act 1998, all public health pesticides and repellents product intended for use against the five vectors in Singapore are required to be registered with the National Environment Agency (NEA). NEA may take necessary actions against those who sell, supply or advertise unregistered pesticides/repellents.
- 3 Pesticides/repellents that are registered with NEA are required to be labelled with a registration mark and indicated clearly for 'General Use' or 'Restricted Use' (Refer to the Annex on how to identify whether a pesticide is for "General Use" or 'Restricted Use').
- The products meant for 'Restricted Use' should only be handled by registered Vector Control Operators, their licensed technicians and certified workers because of the higher toxicity or concentration, or requirement to be dispensed using specific equipment. 'Restricted Use' pesticides should only be supplied to Vector Control Operators and used by their technicians and workers who are trained to handle and carry out application. Mismanagement of 'Restricted Use' pesticides may pose risks to human health or environmental hazards, contamination and pesticide resistance.

Figure 1a: Identifying if a pesticide/repellent is registered with NEA

Pesticide and repellents that are registered with NEA will have a unique registration number in the form of 'SINNEA-X-XXX/XXXX and a registration logo (shown below)




Figure 1b: Identifying "Restricted Use" Pesticides on the product label
